



## Conditions of participation

By participating in the contest, you accept the conditions below without reservation and declare your consent to them.

For the sake of simplicity, only the term «contest» is used in these conditions of participation. However, the conditions also apply to a competition, puzzle game or prize draw.

The contest is open to all natural persons with permanent residence in Switzerland and the Principality of Liechtenstein who are at least 16 years old at the time of participation. The contest participant is the owner of the email address that was declared at the time of registration for the contest. Only one entry per person is permitted. Improper or repeated participation in the contest by a participant will result in his or her exclusion from the contest. Any automated participation or entry or any technical manipulation will also inevitably result in exclusion from the contest. Participation is free and no purchase is necessary.

Only the prizes specified in the contest will be awarded. The prizes will be awarded only among participants who have personally completed all of the input fields required for participation in the contest in a complete, understandable and truthful manner.

PostBus reserves the right to suspend the contest in whole or in part if there is a suspicion that the integrity of the contest is under threat.

PostBus also reserves the right to change these conditions of participation without notice.

Your participation is deemed to indicate consent to the use of the transmitted data for additional offers and information (advertising) and to its transmission (by email or post), storage and processing within Switzerland and the Principality of Liechtenstein. Your details will not be disclosed to third parties.
